### **The Interim Government (IG) Of The Federal Republic Of Ambazonia Condemns In The Strongest Terms The Illegal Abduction Of Mr. Abdul Karim Ali By French Cameroon Soldiers AND Demand For His Immediate And Unconditional Release.**

The Interim Government (IG) of the Federal Republic of Ambazonia has been reliably informed of the illegal abduction of Southern Cameroonian (Ambazonian) advocate and Muslim scholar Mr. Abdul Karim Ali in Bamenda Northern Zone of Southern Cameroons on Thursday the 11th of August 2022, by the terrorist genocidal forces of the French Cameroun Government.

The IG calls on the Government of French Cameroun and her colonial administrators in Bamenda to immediately release Mr. Abdul Karim without preconditions. We are also calling on the International Community, on France, the de facto leader of French Cameroun, on the Muslim religious Communities, and on all other religious groups around the World to prevail on the repressive Government of French Cameroun to unconditionally release Mr. Abdul Karim Ali and the over 3,000 Ambazonians in their prison cells immediately, without preconditions.

The Interim Government, the mouthpiece of the Ambazonian people, stands for the complete and unconditional restoration of the independence of former British Southern Cameroons (Ambazonia). We are appealing to all stakeholders in the International


Community, The UN, The UNSC and all International Human Rights Organizations, to support a peace through Justice negotiated settlement by prevailing on the government of French Cameroun genocidal regime, to come to the negotiation table, and end the humanitarian calamity in Southern Cameroons.
