### *Position Statement*

## **IG Position On LRC's Unwillingness To Commit To A Fair Neutral Third-Party Mediation For A Negotiated Peace Through Justice Political Settlement OF The 5-Years Ongoing Genocidal War In Southern Cameroons - Ambazonia.**

LRC is probably investing on delay and illuding on a military victory or on facilitation of secret background talks with some independentist sellout or spoiler movements, to unofficially pronounce her unwillingness to commit to the Internationally endorsed Swiss-led mediation process, to falsely portray normalcy and maintain her illegal claims of jurisdiction over the Ambazonian territory.

The IG remains committed to a fair neutral third party mediated negotiation process, through the Ambazonian Coalition Team (ACT) or a similarly broad-based constituted body of Ambazonian Liberation groups and extends gratitude to the center for Humanitarian Dialogue (HD) and the Swiss ministry of Foreign Affairs for their continuous engagement to facilitate a fair negotiation process.

The IG reiterates her position that talks with the state of LRC will only take place through a neutral third party, not through any one Cameroun 'Grand

National Dialogue' and further reiterate the resolve of the Ambazonian people to fight LRC to submission and void Ambazonia of any colonial vestige, until total and unconditional restoration of the statehood of the Federal Republic of Ambazonia is attained.

We would like to make it clear that Ambazonia and LRC are two separate states and cannot start any negotiations in a "National Dialogue", which explicitly poses the pre-condition that the conflict is "internal". It is clear and apparent that LRC's previous attempt to treat the conflict as internal and to hand-pick non-representative "dialoguers" failed because of that implied condition and unsustainability. Any sincere wish to resolve the conflict for the long term cannot repeat the mistakes of trying to pull the wool over the eyes of any of the separate state parties as it would leave the same potential for an explosion in future.

The international partners need to be sincere in investing their credibility that they ensure the conditions do not leave them open to questions in future when the situation unravels again. The lack of political will, diplomatic pressure and punitive sanctions from UN sovereign nations and the International Community to address the root causes of the ongoing genocide perpetrated by the Cameroun government on the people of Ambazonia is contrary to the UN's R2P (Responsibility to Protect).
