To the Ambazonian People

RESOLUTIONS OF THE AMBA PEACE PLAN (APP) CONSTITUENT GENERAL ASSEMBLY (CGA) OF 15TH SEPTEMBER 2022

Due to the defunct Restoration Council's (RC) failure to heed RESOLUTIONS 2 and 6 of the APP CGA of 3rd September 2022 convened by the President Mrs. Marianta Njomia, a follow-up APP CGA meeting of Thursday 15th September 2022 with stakeholders from all 13 counties of the Federal Republic of Ambazonia, voted and passed the motions to adopt the following resolutions (RES):

RES 1: Deals Mortgaging Ambazonian Resources

That the Ambazonian Coalition Team (ACT) should convene and issue a communique, denouncing to the International Community and rejecting the outcome of any backdoor discussions or signing of contracts, related to deals to mortgage Ambazonian resources that are single-handedly carried out by individuals or any independent movement on behalf of the Federal Republic of Ambazonia (FRA), without due consultation with other independentist movements. The IG is also mandated by the APP CGA to put out a position statement to this effect.

(Voting: 98% For, 2% Against, 0% Abstention)

RES 2: RC's Flawed Elections

Considering RC's failure to comply with Resolution 6 of the APP CGA of 3rd September 2022, and noting the RC's non-compliance with the people's prescription, the APP CGA

resolves to declare the flawed election organized and conducted by the RC and its outcome NULL and VOID.

(Voting: 100% For, 0% Against, 0% Abstention)

RES 3: Decommissioning The RC

The Ambazonian people, cognizant of the RC's overall lack of representative quorum, overall non-compliance to civic responsibility, underperformance per their Terms of Reference (TOR) and its non-responsiveness to the people's prescription for overhaul, resolve to decommission the defunct RC.

(Voting: 94.5% For, 5.5% Against, 0% Abstention)

RES 4: Presidential Elections

The Ambazonian people, aware of the provisions of RESOLUTIONS 1 and 6 of the APP CGA of 3rd September 2022, resolve to announce and conduct a Presidential election after the adoption of the Electoral Code by the APP CGA and enactment by the President.

(Voting: 94% For, 4% Against, 2% Abstention)
